DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

All Levels pre-entry fees are \$25/per entry

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check. **No entries will be accepted until both entry form and payment has been received.** Please note that exhibitors are fully responsible for credit card chargebacks, including any fees or penalties levied by the credit card company. If entry limits have not been met, day-of entries will be accepted from 7:00 – 7:30 a.m.

WAIT LIST INFORMATION

Tri-State Kennel Club, Inc. is offering a wait list to fill openings created by withdrawn entries after the trial's pre-entry closing date/time. A maximum of **5 entries per day** will be placed on the club's wait list. All entries, including waitlisted entries, must be received by the Trial Secretary prior to **04/25/26, at Noon**. No entries may be withdrawn with a refund after closing on 04/25/26, at Noon. If a withdrawn entry is replaced by a waitlisted entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait list into the trial will receive a full refund.

SIGN-IN and CRATING Areas

There will be a secretary table for check-ins and information.

Crating will be from your car since we will offer Canine Good Citizen & Community Canine Testing inside our climate-controlled building. The building will open at 7 a.m. each day.

ADDITIONAL INFORMATION

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund by the Event Committee or any official thereof.

Collars, Leashes, and Harnesses. Dogs must wear a collar. Dogs may wear slip collars, buckle collars, and Martingales in the AKC Fetch test. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane.

Fetch Testing: Please make sure you read the rules and have the appropriate item you are throwing.

Advanced & Retriever testing: Please read the rules and have the appropriate items to throw. We ask that you bring a few of the items you are throwing so that the steward does not have to run back and forth to the start line each time to give it to you. This will keep the tests moving. It is also helpful to have something to put your thrown items in behind you after each retrieve.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

TESTING AREA:

Judges are not required to wait for dogs. The owner of each dog is solely responsible for having it ready at the test area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the building or test area when required.

EXHIBITOR CHECK-IN: Check-in will be 7:00-7:30 A.M. each day.

Exhibitors MUST check-in EACH day and trial they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations including rabies.


